A Sad Farewell To Bob Dennebaum

His death was briefly mentioned along with a change of address notice in the shortened 2-page Spring 2004 edition of the newsletter. A broader recognition of late PARA member Bob Dennebaum is well deserved.

It was not until Bob left us that the true value of his many contributions became apparent — most of which were performed over and above his responsibilities as treasurer. His regular duties as treasurer encompassed the endorsing and depositing of over 4,000 checks from PARA members each year; making payments to the Alliance of Public Retiree Organizations, printers and others; working along with auditors on the bi-annual audit; and handling innumerable pieces of correspondence from retirees. Among other extra things, Bob also developed and maintained a new PARA retiree's directory complete with changes of addresses, the names of deceased members and an array of other valuable information.

Yes, for all he has done, Bob Dennebaum is greatly appreciated and sorely missed.



A Message From Your President

A brief bio in our last newsletter introduced me as your new president. It stated that I am "concerned that during difficult economic times, the temptation by government at all levels is to cut back on the benefits we have earned. This will be an area that requires attention." I would

like to elaborate on this concern and the role PARA and you as an individual can play to protect and further our interest.

We must continue to be aware of proposed actions by federal and state governments as well as the Port Authority of NY & NJ affecting retirees. We must speak out firmly on matters that affect our interest. However, there is a fine line to be walked, as there are times when we may not want to call undue attention to ourselves. As it has in the past, the board will consider this in view of our larger interests. If the PA sees PARA as nagging and hostile, we will be left with limited access. In Albany, Trenton and Washington, we will have no choice but to coordinate with other organizations that share our views (i.e. the Retired Public Employees Association, Alliance of Public Retirees Organizations, Inc.).

On more than one recent occasion, local governments with the backing of Governor Pataki, have tried to cut back or substantially delay the contribution that government employers are required to make to the state pension fund. This was the subject of a warning contained in a letter in April of this year from New York State Comptroller Alan Hevesi to all retirees. On your behalf as part of a vigorous lobbying campaign, both Al Rubbert and I have written to Mr. Hevesi.

Hevesi, trustee for the pension funds, appears to take his fiduciary obligation to retirees seriously. After contacting Hevesi's office, we are in the process of making arrangements to have a representative meet with your board in an effort to improve communications with our trustee.


Another example of how issues of concern may arise is a recent change in Medicare that provides some prescription drug coverage. This change may tempt governmental employers to cut back or eliminate employee drug coverage (I am not aware of any plan by the PA to do this). This is one reason why improved communications with the Human Resources Department of the Port Authority is vital. There was a time when many of us referred to the PA as "Mother PONYA" because in some ways it was a family. Over the past years, major personnel and structural changes have occurred at the PA. It is no longer prudent to assume that those making economic decisions will protect the interest of retirees. Your board will strive to be alert. I ask that you please let us know of matters not widely known that will impact retirees. If you have a close relationship with a decision maker (i.e. a commissioner, assemblyman or senator), please let us know. Finally, when we request that you write to a particular official and you agree with the position we are taking, please take the time to write... there is strength in unity.

CAN THE GOVERNOR TOUCH THE COMMON RETIREMENT FUND WITHOUT THE APPROVAL OF THE COMPTROLLER?



No, and not even with the approval of the comptroller which, by the way, Comptroller Hevesi has no intention of giving. The State Court of Appeals has ruled that both the comptroller and the state have equal fiduciary responsibilities to the fund and the assets of the fund cannot be used to solve the fiscal problems of the state.



WHY DO SOME LEGISLATORS PERSIST IN SAYING THAT GOVERNOR PATAKI'S PROPOSAL IS NOT A "RAID" ON THE COMMON RETIREMENT FUND?



These legislators, the governor and the budget director, are playing with words. Their proposals don't actually take money out of the Common Retirement Fund this year — they just don't put in enough money to actuarially fully fund it. None of their proposals indicate how they expect to achieve full funding. They may hope the stock market will rebound far beyond their own or anybody else's projections. Failing this, the burden will be put on future generations to pay for current retirement benefits.



IS THE GOVERNOR TRYING TO MAKE THE OFFICE OF THE COMPTROLLER AN APPOINTED OFFICE?



He would probably like to at this point, but he would need to change the state constitution to do it.



CAN OUR COLA BE TAKEN AWAY?

Only technically. He is asking the comptroller to illegally do what he and his predecessors have been barred from doing by the courts. Happily, Comptroller Hevesi has not and will not comply.

Meet Your New Officers

President Richard Helman. Upon his graduation in 1961 from Columbia Law School, Richard Helman joined the PA Law Dept. By the time of his retirement in 1995, Dick had served as Chief of Litigation and later as Chief of Commercial Litigation. For over 30 years, he has been on the faculty of New York University and is presently an adjunct Associate Professor of Real Estate teaching a law course at the graduate level. Dick is up to the task of President and will lead PARA to bigger and better things.

Treasurer Henry Lee. The PA employment of Henry Lee spanned from 1968 to 1999 - the year that he retired from a position as Manager/Administration, Comptroller's Dept. For his first 20 years, Henry held a variety of positions in what was then the Personnel Dept. The most notable was client representative. Henry hired many of the technical personnel involved in design and construction of major PA facilities. He holds a BS degree from Syracuse University and an MBA from Long Island University. Henry's energy and expertise will have a positive impact on your association.

Al Rubbert, chairman emeritus and former PARA president, is filling in as an assistant to PARA's new treasurer, Henry Lee, until the end of the year.

Secretary Robert Jago. Since early this year, Robert Jago has been serving as PARA Secretary. In the December newsletter, it was mentioned that Bob joined the board. It is appropriate to highlight some other aspects of his career. Starting as a police officer serving at various PA facilities, Bob transferred to administration in 1962. Following a stint as management trainee, he moved through a series of promotions in the former Personnel and Rail Transportation Depts. In 1979, he was promoted to executive assistant, Law Dept. - a position he held until retiring from the PA in 1989. Since then, Bob has volunteered at over 40 golf tournaments that benefited various health related programs and charities.

Goals and Objectives 2004-2005

- Continue to work with the New York State Comptroller and the Alliance of Public Retiree Organizations to seek passage of legislation that would increase the current permanent COLA from 50% of the CPI to 100%.
- Continue to develop a retiree network in conjunction with the alliance to meet with every member of the New York Legislature on matters affecting retirees.
- **3.** Continue dialogue with NY-NJ-FL Congressional members to ensure that senior's economic status is not diminished by any legislation.
- 4. Meet periodically with the PA Executive Director, Chief Operating Officer, Chief of Staff and Human Resources Dept. to continue rapport and support for PARA and PA.
- 5. Maintain liaison with the PA PBA retiree organization, Last Wednesday of the Month Club and other PA retiree groups to expand PARA prominence.
- **6.** Publish at least 2 newsletters annually and special newsletters as deemed necessary.
- Adhere to a quarterly Board of Director's meeting schedule with two meetings in NJ and two in NY facilities.
- **8.** Monitor the by-laws to ensure that they reflect the changing nature of PARA as necessary.

How To Save Money On Hotel Rooms

Here are some suggestions from travel experts and experienced travelers on finding a hotel room for less than the listed price:

1. Ask a Travel Agent. Inquire about unpublished sales going on in the area you're planning to visit. 2 Travel Off-Season.

Hotel prices drop significantly during off-season and weekend rates are usually much lower than weekday business rates. And try not to stay in a city during a major convention. 3. Request a Status Discount. For people over age 60, most hotels offer 10% discounts. For members of AARP, National Alliance of Senior Citizens or Silver Keys, the discount is more. Many hotels will also offer a discount to students, veterans, young adults and members of AAA, business organizations or other groups. **4. Call Direct.** You will almost always save money by contacting the hotel directly instead of booking through the chain's toll-free number. Book your room well in advance so the hotel agent knows you have time to shop around. Don't accept the first rate offered to you as many hotels have a fall back rate (they will quote it if, and only if, a customer is reluctant to accept the standard rate). 5 Try Booking Through The Airline. Many international air carriers have established relationships with foreign hotel chains that can save you money when traveling overseas. 6. Call a Hotel Consolidator. Consolidators such as Quickbook (800-789-9887, www.quickbook.com) book blocks of rooms months in advance at steep discounts.

Leon Goodman Receives Award

Leon Goodman, who retired from the Port Authority in 1992, received the Burton W. Marsh Distinguished Service Award from the Institute of Transportation Engineers (ITE) in August 2004. He is the third person from the Port Authority to be selected for this award. Previous PA recipients were Edward Wetzel (1971) and Alan Gonseth (1986). The award, one of ITE's highest honors, was presented at the ITE Annual Meeting in Orlando. ITE is the leading international,

multimodal transportation

professional society, with over 16,000 members in 90 countries. Leon's ITE activities included service on the ITE Board, as ITE international president and as chair of the ITE Transit Council. He was manager of transportation planning in the PA's Planning and Rail Development Department.

Lee continues his work as a consultant in traffic engineering and transportation planning.



As part of the Human
Resources Department's ongoing
commitment to ensure the privacy
of health care information, protect
current and retired employees
against identify theft and to
comply with recent federal HIPAA
legislation, all active and retired
employees enrolled in United
Healthcare will soon receive or
have already received new health
ID cards. They no longer have
social security numbers listed.

An alternate identifier provided by United Healthcare has replaced the social security number. This unique number can be used when contacting United Healthcare and, in fact, has been used on correspondence received from United Healthcare over the past several months (such as an Explanation of Benefits statement). In addition, the new plastic ID card is more durable. It is also more convenient because all covered family members are listed on the card. A magnetic strip on the back of the card will enable eligibility and co-payment information to be verified electronically by the doctor or hospital, simplifying the check-in process. The level of benefits remains the same and United Healthcare has assured us that it will continue to provide the superior level of service to which current employees and retirees are accustomed.
