Board Highlights

The second Quarterly Meeting of the Board of Directors was held on April 24, 2019, at Times Square Hall in the Port Authority Bus Terminal. Present at the meeting were Katie Cann, Blair Wegescheide and Anily Palacios, Leadership Fellows from the Port Authority and the planning team for Remembrance Through Renewal (RTR), a program held during the month of September that brings awareness to and honors the memory of our friends and colleagues lost on 9/11. The program partners with the communities and community organizations in a variety of events such as food pantries, shelters, parks renovation and a host of other objectives for which Port Authority employees and retirees volunteer their help. All retirees were encouraged to participate. Also part of this program was a Pillars of the Community award, presented on September 4 for the categories of public service, industry expertise and strength and resilience. Several PARA Board members and PARA Representatives participated in the review and selection of the award recipients.

Committee reports were given. December was a heavy dues collection month and new members are joining on a slow but regular basis. The PARA Board members discussed the idea of forming a scholarship fund but no action was taken as further discussion is required. The PARA newsletter will continue to be sent to the PA Executive staff and will be expanded to the Chiefs so that they may provide information for events and articles for future issues. PARA will continue to attend the Port Authority pre-retirement seminars whenever they are held to further our recruitment effort.

The Annual Meeting and third Quarterly Meeting were held on July 10, 2019, at the Port Authority Bus Terminal. Present at the meeting were guest PARA members James Filipone, Vivian Jenkins Johnson, Lou Venech and Howard Bonsaing. President Gallagher welcomed the guests and reviewed various issues brought to the attention of the membership throughout the year. He also reported that Jameson Doig, who wrote a book on the history of the Port Authority from its inception to 1950 entitled "Empire on the Hudson" is now collaborating with several colleagues from local universities on a sequel entitled "Mobilizing the Metropolis" documenting events from 1950 to present. He then recognized George Jensen on his retirement from the Board and thanked him for his years of service and all his contributions and insight. Steve Borrelli will take over George's role as Chairman of the Finance Committee. Director Rinaldi was involved in stabilizing The World

Trade Center slurry wall after 9/11 and was invited by the Memorial Museum to participate in a panel discussion on the history of the structure. Director Hoffmann met with the Museum's curator regarding Port Authority artifacts and items that may be available for donation to the Museum's collection. PARA guest, Lou Venech, discussed creating an archive of all Port Authority artifacts that can be gathered in time for the Port Authority centennial in 2021. Further information on this effort will be forthcoming.

The election results were accepted which reinstated President Gallagher, Vice-President Hoffmann, Secretary Raczynski, Treasurer Isaacs and Assistant Treasurer Cutler for a term of one year or until superseded. It also approved the following Directors for three-year terms: Isaacs, Philmus, Raczynski, Morrow, Karvasarsky, Somerwitz, Malone-Hodges, Eastman and Murtagh.

At the third Quarterly meeting, the PARA Board discussed the new Tier 6 benefit plan. Certain non-represented, eligible employees have the option to either stay with the New York State Retirement System or go to another contributory (401 type) retirement plan which they can take with them should they leave. The PARA Board is considering adding additional sections to the newsletter such as "letters to the editor" and "photo flashbacks." In addition, the newsletter will list those PA colleagues that we have lost. The PARA website continues to be a vital part of this organization and our singular webmaster, Joe SanSevero, who built the website continues to do a masterful job of managing and protecting it from the myriad hacks it receives on a daily basis. Backup for PARA's website is being explored. The Port Authority labor agreements still have some unresolved issues which are being worked out. PARA will be available to disseminate information to retirees should that become necessary.

WTC Memorial Golf Club & Invitational

The WTC Memorial Golf Club was started following the tragic losses of September 11, 2001 and was later established as a nonprofit 501(c)(3) Public Charity incorporated under the name WTC Memorial Fund, Inc.

In 2002, at Pebble Creek Golf Course in New Jersey, Port Authority employees along with other supporters got together on the golf course for the first annual WTC Memorial Golf Invitational to reflect and honor the 90 friends and colleagues who lost their lives on February 26, 1993 and September 11, 2001 terrorist attacks. The mission of the WTC Fund is to continue to raise money for charitable and worthy organizations or individuals with both financial assistance and donations. To date, over four hundred thousand dollars has been donated to multiple charities. The WTC Fund also provides college scholarships in the names of those lost in the terrorist attacks at the WTC and plans to erect and maintain a monument at the ground zero site dedicated to the employees of The Port Authority of NY & NJ lost in the attacks.

Every September, on the Friday after the 11th, the WTC Memorial Golf Invitational is held and for those who don't want to play golf, they are always welcome to attend and join in for the luncheon and activities. Acknowledgment before the start every year begins with a moment of silence and prayer for our friends and colleagues that were lost and those that continue to become ill.

This year on September 13, opening remarks by WTC Fund Committee President, Paul lannacone, welcomed all the attendees, thanked all the many supporters and noted some of the additional ways that our fallen friends will be remembered. He stated that, to date, we know of 11 Port Authority Police Officers that have passed as a result of the recognized 9/11 illnesses contracted from toxins at and around ground zero. In 2019, TB&T's Operations Duty Manager,



Christopher O'Halloran, was another employee that was diagnosed with lung cancer attributed to his 9/11 exposure, and after a valiant battle

with cancer, sadly passed on June 20.

He also mentioned, sadly, that individual pavers dedicated "In Loving Memory" will be placed at the Pebble Creek WTC Memorial for those we lost during the year. Paul then called for a moment of silence, acknowledging all those that have passed.

The moment was accompanied by a single bagpiper, Anthony Sierra from the Port Authority Police, who piped slow and somber melody Amazing Grace in their remembrance. Also recognized,



was committee Vice President John Foye, whose father recently passed. John's father, Jack, was part of the Belmar Fishing Club and has provided significant donations these past eighteen years. The Belmar Club donated one thousand dollars on his behalf.

Reaffirmed was the recent loss of TB&T employee Chris O'Halloran, who was also a US Navy Veteran, and both a supporter of the Fund and attendee at every outing since 2002. He further remarked how others continue to struggle with conditions associated with September 11.

Paul then introduced Committee Trustee Bob McKee, who followed with a heartfelt speech noting Chris' service to our country, contributions of his more than three decades of Port Authority service, his response on September 11, 2001, and his support in the weeks and months following. In part, are some of the words Bob expressed; sentiments we all live each day.



"We will never forget" - those words resonate through all of us. They say that "time heals all wounds" but I don't know when it comes to September 11. It seems that all too often, we hear of another first responder either becoming ill or passing away as a result of their exposure to the toxins from that horrible event

In fact, over time, sadly more first responders, construction workers. innocent people who worked in the WTC and in the vicinity of the WTC, and others who happened to be in the wrong place at the wrong time, will die as a result of their exposure to the elements from September 11 during the months of rescue and recovery operations that followed. Unfortunately, more of these individuals will die and far surpass the number of people lost on September 11. Meanwhile, thousands of others will be permanently impacted by illness and sickness.

As Physical Plant Manager of the Holland Tunnel, I had the privilege, as many of you did, of working with Chris on September 11 and the days, weeks, and months that followed. Chris responded to the emergency that day as did thousands of first responders, including Port Authority Police and other Port Authority personnel.

WTC Fund Scholarships

On September 11, 2001, 38 Port Authority civilian employees and 37 Port Authority Police died in the terrorist attacks on The World Trade Center. Five employees died in a bombing before that on February 26, 1993. In their memory and for their selfless actions the WTC Memorial Golf Club Committee is awarding an annual scholarship to graduating high school seniors who plan to continue their education beyond high school, in the amount of \$15,000 for a 4-year undergraduate degree and \$7,500 for a 2-year associate degree. To receive the full benefit of the scholarship, the recipient must maintain a 3.0 GPA while in college.

The Fund's Committee is made up of family members of those who lost their lives in 1993 and 2001. The purpose of the scholarship is to recognize a graduating senior annually who has the desire to further their education. The program has been awarding scholarships since 2014.

Paul and Scholarship Committee Chair Jessica Dobrin continued with the announcements of the annual WTC Scholarship awards. This year presentations were made to Brook Matthews, the daughter of Holland Tunnel's Maintenance Supervisor Mike Matthews, in the amount of \$15,000 over 4 years, and the second award went to Ashley Pepe, daughter of Police Officer Tom Pepe, for a one-time amount of \$2,500. Since 2104, the WTC Fund has awarded over \$110,000 to 13 recipients.

Note: WTC Scholarship Awards are only awarded to family members of those Port Authority employees who lost their lives in 1993 and 2001. The reference to five employees from the 1993 attack includes an unborn child.



Established with the support of owner Ray Longobardi at the Pebble Creek Golf Course, is a permanent Memorial. Three large Memorial Stones, donated by the support of WTC Golf Club/ Fund, the Port Authority PBA and the Pebble Creek Golf Course have been placed and are engraved to include words of recognition and the names of all those lost in both WTC attacks. In part, "This place of remembrance On September 11, 2001 the Port Authority lost 84 co-workers and friends. This memorial honors their memory and all others who perished in The World Trade Center," and goes on "We will never forget those Port Authority workers and friends who we lost on February 26, 1993".

The tall black stones are interconnected by dozens of individual and group

pavers have been placed in the memorial area that include both personal and group dedications and sentiments to permanently beautify the reflective grounds.

This section of steel was salvaged from the WTC after the attacks on September 11, 2001 and has been permanently placed at the memorial site at Pebble Creek. This steel piece of the Twin Tower "Tridents" also has a sister section that is displayed in the atrium of the National September 11 Museum.

This year's event hosted 245 golfers, and more than 50 friends, family, coworkers, retirees and sponsors joining in the luncheon and activities.

Closing remarks by Paul Iannacone reasserted the Committee's recognition of all the employees, retirees, other attendees, the many sponsors, the Port Authority Unions and the Pebble Creek owner Ray Longobardi and staff for their continued support these past eighteen years and that we will never forget our fallen friends.

For months afterwards, Chris supported recovery operations in any way that he could, even on his own time.

Chris had a larger than life personality and was an avid golfer, shooting 7 holes-in-one during his lifetime. He attended this WTC outing for the last 17 years and always looked forward to it. He will always be with us in spirit."

Following these kind words, a Flag Box, coordinated by Trustee Lou

Gallo, and handcrafted by Joe Piekarz, and John Degenova of the Holland Tunnel where Chris last worked, was presented to Chris' son Steven, to display the United States Flag that graced his coffin. Closing words from Bob McKee, sustaining the phrase "We will never forget", underpinned the steadfast commitment of the WTC Fund Board, our employees, our unions and many other supporters, to those we lost and those that continue to suffer.

Remembrance Through Renewal

or the fourth year, members of PARA participated in the Port Authority's Remembrance Through Renewal program. This month-long series of service events which pays tribute to those we lost on 9/11 was once again a resounding success. Over 35 members of PARA participated in this year's program consisting of 22 community-based events. To close out the month long program of service, the Port Authority instituted the Remembrance Walk and Reflection Ceremony. inaugural Remembrance Walk consisted of a candlelight walk around the WTC Memorial and Museum, ending in a ceremony in Liberty Park on the evening of October 2. The PAPD's Pipe and Drums led the walkers. Executive Director Rick Cotton opened the ceremony, making remarks on the agency's remarkable ability to move on despite the horrors of 9/11. PARA Board members Frank Lombardi, retired Chief Engineer, and Peter Rinaldi, retired Assistant Director of Engineering, offered their thoughts on resilience and their personal 9/11 experiences at the Liberty Park ceremony. PAPD Deputy Chief Raymond Bryan also spoke about his deep connection to the events of 9/11.

NJ football: Story behind 9/11 memorial flag Piscataway will unfurl Friday night

The meeting was held in room 129, a lecture hall in Piscataway High School, on Thursday, September 12, 2019.

After the Piscataway football team completed a walk through on the field, players and coaches retreated to the high school for a weekly awards presentation, during which the top performers from the previous game were honored. This week's meeting, which took place on Thursday in Room 129, a lecture hall with auditorium style seating, concluded with junior lineman Nick Lodato being selected to lead his team onto the field against Sayreville Friday night.

Lodato will be carrying a Port Authority of New

York and New Jersey World Trade Center Memorial flag that proudly flew at The World Trade Center and has been displayed at military bases around the world bearing an image of the twin towers across which Old Glory is superimposed. The Port Authority of New York and New Jersey Sign Shop designed and created the flag after the Sept. 11 terrorist attacks.

The flag, of which there are replicas, is the property of recently retired Port Authority employee Bob McKee, who most recently served as general manager of redevelopment for The World Trade Center and who is the father of Piscataway quarterback's coach Nick McKee.

"I gave them a little history of Sept. 11," Nick McKee said of his talk with the players in Room 129.

"(Piscataway) Coach (Dan) Higgins has got a saying. When something gets botched up on the field, you reload." The word reload is part of Piscataway football lore and players recite it from the sidelines in unison while thumping their thigh pads with their hands following a penalty or a miscue.

"When I asked the kids what did we do as a country after Sept. 11," Nick McKee said, "I told them we reloaded. I could tell I had their attention. I tried to look at everybody's eyes in the room. I could tell how much (Lodato) respected the flag when he got it in his arms. He made sure it didn't touch the ground."

Navy SEALs in Iraq and U.S. Army soldiers

in Afghanistan, where the Global War on Terrorism, a United States-led international military campaign in response to the Sept. 11 attacks is being fought, have proudly displayed Bob McKee's flag.

On Sept. 11, 2001, terrorists hijacked four planes that killed nearly 3,000 people in New York City, Washington D.C. and Stonycreek Township, Pennsylvania. Among the victims were Sayreville residents Vinod K. Parakat and Robert T. "Bobby" Hughes Jr., and Piscataway

> residents Harry Glenn, Liming (Michael) Gu and Yeshavant Moreshwar Tembe.

> "I'm very proud," Bob McKee said of Piscataway taking the field with his flag. "I think a lot of people have forgotten what that day was like. For younger generations, some of these kids were infants and maybe not even born. They really don't understand the impact it made on the world. I think it's important for everyone to fully understand what happened that day."

> Of the flag, Bob McKee said the Port Authority, "Came up with the concept that they wanted to permanently establish something meaningful to the Port Authority, and their vision was having The World Trade

Center towers and the American flag."

Bob McKee said the design of the flag became so popular that decals bearing the image were made for first responders, military personnel and others to wear.

"When the military was sent abroad to attack, a lot of the airplanes, ships and even bombs that were dropped carried that same logo," Bob McKee said. "It signifies that we will never forget those that were lost on 9/11."

> Bob McKee is the son of a mechanical and industrial engineer who also worked for the Port Authority, which oversees much of the regional transportation infrastructure - including bridges, tunnels, airports, and seaports within the New York-metropolitan area's port district. Bob McKee said his father was involved in the design and construction of the original World Trade Center and that he had "the good fortune to work on the building of the new World Trade Center."

> "That was the pinnacle of my career," Bob McKee said, "and with the new World Trade Center, its bigger and stronger, so it sends an important message out to New York City and the world that we will never be kept down as Americans, and that we will never forget."

The deadly Sept. 11 attacks, which al Qaeda leader Osama bin Laden orchestrated, occurred at The World Trade Center, the Pentagon and aboard United Airlines Flight 93. More than 2,700 people died at The World Trade Center after two hijacked planes intentionally crashed into the north and south towers. Those who perished included 343 New York City firefighters, 37 Port Authority police officers and 23 New York City police officers.

The death toll has risen as first responders, firefighters, police officers, EMS technicians, construction workers and others who volunteered at Ground Zero died as the

Most recently, we announced that the Service Delivery team is using the Customer Relationship Management (CXm) system which provides the team with a significant tool that is used to implement best practice methods to track and reference calls from employees, creating a single reference data base for call management and case resolution. The implementation of this system will improve the service we provide to everyone who calls the Service Delivery Call Center.

By streamlining our business processes, we aim for quicker problem-solving and case management. Effective immediately, you can begin using this email address to send your general inquiries, including the following topics listed below:

Pension Fund Shows Strong Growth

Comptroller Tom DiNapoli has reported that the value of the Pension Fund has risen to \$216.2 billion, following a robust return of 3.4% in the first quarter of the state fiscal year, which ended on June 30th.

Comptroller DiNapoli stated, "The fund is off to a strong start this fiscal year. Markets have been volatile, however, warranting caution from investors. Our constant goal is to ensure that New York State's pension fund remains one of the nation's strongest and best funded, providing state and municipal employees with retirement security for generations to come."

This is indeed good news. In June, the Pew Charitable Trusts once again ranked the New York Pension Fund one of the best funded in the nation, with a funded ratio of 96.1 percent. Only eight states had a funded ratio of 90 percent or higher based on 2017 data, with New York ranked fourth behind Wisconsin, South Dakota and Tennessee.

In other news related to the Pension Fund, Comptroller DiNapoli announced that the employer contribution rate for the Employees' Retirement System for the next fiscal year will remain the same, while the Police and Fire Retirement System will have a slight increase. Taking a conservative approach to future market environments, the Comptroller also lowered the anticipated rate of return on investments from 7 percent to 6.8 percent.

RPEA commends Comptroller DiNapoli on his outstanding stewardship as "Sole Trustee" of the Pension Fund, ensuring a safe retirement for current and future retirees.



Reporting a Member's or Retiree's Death to NYSLRS

When a NYSLRS member dies, whether before or after retirement, it's important that survivors report a member's or retiree's death to NYSLRS as soon as possible. Survivors can report a death by email, phone or mail. They will need to send NYSLRS an original certified copy of the member's death certificate regardless of how they notify NYSLRS.

Once NYSLRS receives the death certificate, they will send beneficiaries or their certified representatives (guardians, powers of

attorney, executors) information about death benefits and, if applicable, information about continuing monthly retirement benefits. They will also send them forms to complete. Beneficiaries should be aware that it could take **three months** from the date NYSLRS is notified of the death before any death benefit is paid or any monthly benefit payment begins.

If a member is retired when he or she dies, NYSLRS will stop payment of any outgoing pension benefits. Survivors should be aware that any uncashed pension checks in a deceased retiree's name must be returned to NYSLRS. NYSLRS will automatically reclaim any direct deposit payments that went out after a member's death. See below chart for options to report a death.



What Happens Next

Once we receive the death certificate, we will contact and provide forms to the named beneficiaries or certified representatives (guardians, powers of attorney, executors).

It can take three months from the date we are notified of the death to process the required forms.



result of inhaling toxic substances from a dust cloud the twin towers' collapse generated.

"It is definitely a very difficult anniversary," said Bob McKee, who was stationed on Sept. 11 at the Holland Tunnel, the closest Port Authority facility to The World Trade Center and the facility of which he was the physical plant manager at the time.

"Every time you read something in the paper, it's like a wound that never heals. Many first responders and people that were exposed to 9/11 toxins have since died, and that's going to carry on, unfortunately."

Earlier this year, President Donald Trump signed into law a bill that in effect permanently reauthorizes the September 11th Victim Compensation Fund, which pays out claims for deaths and illnesses related to first responders who fell ill after working at Ground Zero or the Pentagon in the aftermath of the Sept. 11 attacks.

"The bill that has been passed," Bob McKee said, "will help people who have been sick, injured and died from that event."

Bob McKee is a committee member for The World Trade Center Memorial Golf Club, which holds an outing every September on the first Friday after the 11th of the month at Pebble Creek Golf Club in Colts Neck, New Jersey. The outing, held annually since 2002 and during which participants take time to honor and reflect upon those who died as a result of the Sept. 11 attacks, has raised more than \$300,000 for charitable organizations and has funded college scholarships in the names of those lost in the terrorist attack on The World Trade Center.

Nick McKee, who has been a part of the golf outing since its inception, will return from the links in plenty of time to watch Lodato run onto the field with his father's flag.
