PANYNJ Centennial Notes

As the Port Authority's 100th Anniversary project winds down toward year-end, PARA members should keep an eye on the agency website's Centennial section — https://www.panynj.gov/port-authority/en/Centennial.html — for additional postings. The agency's archives rebuilding initiative is continuing beyond this year. Members who want to donate relevant objects or copies of photos or documents should contact Alfred P. Board Highlights

Both the April 19, 2021 and the July 13, 2021 Quarterly Meetings of the Board of Directors were held via Zoom technology due to the continuing COVID-19 pandemic. Highlights of the April meeting are as follows: Director Isaacs reported slow dues collection in the first quarter. For the first time PARA expenses surpassed its quarterly income as a result of the annual honorarium for our webmaster. Otherwise, there were no significant expenditures. Overall finances are in good shape. He did notice an inconsistency in dues payment in general and a discussion followed and suggestions were offered as to how to reach and/or restrict non-dues paying members from certain publications.

Director Venech reported that he solicited Board members and retirees to submit stories about their careers and experiences for the Spring newsletter and got about 85 responses, many very heartwarming. Since there was too much content to include all the submittals in the newsletter due to the prohibitive cost, it was decided to compile an archive with the full content of everyone's responses on the PARA website, which could be expanded as more stories are received.

In a continuing effort to recruit new members, Director Malone-Hodges reported that she is trying to get information on any upcoming pre-retirement seminars and information on the group of people that may be retiring in the near future. She continues to work with HR on this. Directors Malone-Hodges and Hadley-Bailey will work on getting non-police and police members signed up and dues paid.

Director Blauser led the effort to turn over the Presidency of PARA. As you now may be aware, Karen Eastman has graciously accepted the role of President. Director Blauser thanked Dave for his much-appreciated role and all his hard work over the years. President Gallagher in turn expressed thanks to the Board and happiness for the outcome. Director DiMola suggested PARA take part in the 20th anniversary of 9/11 and that it would be most appropriate for retirees with firsthand experiences to have a presence at the podium for whatever may be planned. Director Malone-Hodges suggested that PARA continue to work on the Pillars of the Port Authority awards committee as well. Director Philmus suggested a delegation of PARA members attend the ceremony.

Director DuBrow has established a new Benefits Committee which was subsequently approved by the Board, to address our members' concerns regarding PA benefits. Director DuBrow will be the point person and liaison with HR. Retirees with benefit issues are always advised to contact HR directly for assistance. The Committee members are Directors DuBrow, Gallagher, Eastman, Hoffmann, Hellenbrecht, Malone-Hodges, and Joe SanSevero as an adjunct member. She also reported that HR is looking into installing a benefits portal for information dissemination. Director DeLaura reported that many of the retiree luncheon groups are beginning to plan in-person luncheons again.

At the July meeting Treasurer Isaacs summarized the voting process. The election results were accepted which approved Director Eastman as President, and the following Directors for 3-year terms: DeLaura, DiMola, DuBrow, Graser, Hadley-Bailey, Hellenbrecht, Lee and Tucker. Also, the following Board officers were re-elected for a term of one year or until superseded: Vice-President Hoffmann, Secretary Raczynski, Treasurer Isaacs and Assistant Treasurer Cutler. At that point the meeting was turned over to Karen Eastman, the incoming President. Committee reports were given. June was a good dues collection month in spite of the high cost of printing and mailing the newsletter. The audit for the 2019-2020 period was completed this year by Bob Sudman, former Port Authority Audit Director. PARA thanks Bob for his participation and hopes that he will continue to perform this function in the future. Director Venech mentioned that there now is a special section on the PARA website where all the retiree centennial stories were posted, with thanks to webmaster Joe Sansevero. Port Authority staff helped out by providing photos to go along with some of the stories. Director Hoffmann reported that the new website production is ongoing. The web designer, Go-Daddy, has improved the design which is now between 80 percent and 90 percent complete. We may have to change the input call-in contractor because Go-Daddy is lagging on this particular task.

PA Benefits has notified PARA that in the future they will not be sending out reminders to file for Medicare Part B reimbursement benefits. It will be the retirees' responsibility.

PARA will continue to remind its members, however, there are eligible people who are not PARA members who may never get notification. Per HR, there are no pre-retirement seminars scheduled at this time. We will be notified when they resume. Directors Malone-Hodges and Hadley-Bailey continue the recruitment effort.

Acting in consultation with the Executive Committee, on September 2 Secretary Raczynski circulated the following proposal for Board consideration: "PARA is entering a period whereby its membership is showing a decline and there is a need to reach out to prospective retirees and encourage membership. In addition, PARA's participation in certain Port Authority events and its continuing liaison with staff is a critical component to the success of its mission. Therefore, it is recommended that we fill the position of Second Vice-President with Maria Malone-

Hodges. Maria has the necessary skills, maintains the necessary relationships with Port Authority staff, and is currently performing these important responsibilities on behalf of the Board.

Therefore, in accordance with Article V, Section 1, of the By-laws of the Port Authority Retirees Association, a recommendation is hereby made to appoint Maria Malone-Hodges to the position of Vice-President, effective immediately and until such time as the re-election of the PARA Board Officers is held."

This recommendation was approved via email balloting of the Board. Subsequently, VP Malone-Hodges reported that Cynthia Hadley-Bailey has agreed to succeed her as Chair of the PARA Membership Committee.


Centennial Commemorative Items Available Now

Remembrance, Renewal, Resilience

I still remember clearly the last time I sat in my engineering office on the 72nd floor of the Trade Center. It was a Friday afternoon just days before the sad events of 9/11. Having just finished reviewing and signing hundreds of contract drawings for the replacement and modernization of the Holland Tunnel's original ventilation system (the first of its kind when the tunnel opened in 1927), I was looking forward to a two-week vacation with my wife on the Outer Banks of North Carolina. Little did I know then that I would be returning a week later to mourn the loss of so many of our friends and colleagues and find myself being part of the emergency response and recovery team at what was once the World Trade Center.

It was there, while on the pile as we called it, one day in late September, that the smoke and acrid smell in the air, brought me back to another Friday afternoon, eight years earlier. It was the memory of those hours trapped in a dark, smoke-filled elevator after a terrorist bomb exploded in the basement of our building. There were nine of us in that small elevator that day, including then Chief Engineer, Gene Fasullo and future Chief Engineer, Frank Lombardi. cutting our way out of the elevator shaft, we groped our way down pitch black, smoky stairways to daylight and safety, a similar experience shared by thousands and thousands of others evacuating that day.

In a show of resilience, agency staff banded together and had the World Trade Center fully back up and running in just three weeks. Then, learning from that slow evacuation experience, went on to implement safety improvements that would prove

prescient. Among these improvements were the placement of batterypowered floodlights in all the stairwells of the Trade Center, as well as luminescent strips on the stairs and handrails. Because of the loss of power that day and the ensuing darkness in the stairwells, it was several hours before everyone was able to make their way down and out of the buildings. Importantly, agency staff developed emergency evacuation procedures and ran drills periodically for everyone in the buildings.

Today, we remember all those lost on that terrible day 20 years ago, and rightfully so. But we should also remember that thousands and thousands of others made it out safely that day. I am convinced that the toll could have been much worse had it not been for those lessons learned and improvements that were made in the aftermath of the 1993 Bombing.



To enroll, PARA members can go to the website and sign up for e-bulletins.

PARA would like to thank the Total Rewards - Benefits Division of the Port Authority HR Department for the following article and other information provided to PARA regarding important reminders and updates for Port Authority/PATH retirees.

Updates from Human Resources - Employee Benefits

In an effort to better serve our customers, the Human Resources Department has made a few changes as it pertains to Employee Benefits. We believe these changes will support our mission of providing an outstanding customer experience, while we continue to make it a point to gain a better understanding of our employee's/retiree's requests.

Moving forward, we ask that all inquiries related to Benefits be sent to hr_employeebenefits@panynj.gov – this dedicated mailbox will help us streamline our business processes and connect you with a Benefits Subject Matter Expert to get you a response more efficiently. Effective immediately, you can begin using this email address to send your benefits inquiries, including but not limited to:

- Medical, Dental & Life Insurance eligibility and coverage level inquiries
- Submitting PA 2298 Employee Status Change form with the relevant documentation
- Obtaining forms related to life insurance, medical and dental claim forms
- Medicare
- Change of Address request

To monitor inquiries and ensure we are meeting the needs of our customers, we will continue using the Customer Relationship Management (CXm) system, which provides the team with a significant tool used to implement best practice methods to track and reference calls from employees/retirees. This creates a single reference database for call management and case resolution – allowing us to work more efficiently to handle inquiries.

One of the most frequent questions we get from retirees is around Medicare. With that, here are some important things to remember about Medicare:

- Medicare is a federal health insurance program for eligible U.S. citizens and legal residents. It is funded in part by taxes you pay while working. Medicare is not a family health plan. It is not Social Security, Medicaid or free.
- Medicare benefits become effective the first of the month in which the retiree and/or spouse turn age 65 or becomes eligible for Medicare (Under 65, have a disability and are receiving disability benefits from Social Security or certain disability benefits from the Railroad Retirement Board for 24 months).
- At the time of Medicare eligibility, the retiree or spouse must enroll in Medicare Part A and Part B to ensure full continuation under the Port Authority/PATH retiree health plan. A copy of your Medicare card with your Medicare Health Identification Claim (HIC) Number must be provided to Employee Benefits. It is also the responsibility of the Medicare recipient under age 65 to notify Employee Benefits of the date of their Medicare eligibility and to provide a copy of their Medicare card with the Health Identification Claim (HIC) Number.
- We will then send the information to the Center for Medicare and Medicaid and once approved, we will move your Prescription Plan from the active plan to a comparable Medicare Part D plan. This will ensure continuation of your Prescription Plan, through Express Scripts, without you having to get a Part D plan elsewhere.
- You need to enroll in Medicare Part A and Part B as soon as you become eligible. If you wait, you may be assessed penalties by the Center for Medicare & Medicaid Services (CMS) for late enrollment
- Look out for new cards from United Healthcare (it will say "Indemnity" in the right-hand corner) and Express Scripts (it will have the new group "JMP") that are exclusive to you.
- If applicable, your National Vision Administrators plan, MetLife Dental or Dentcare will remain the same.

If you are looking for more information on Medicare like how claims are processed when Medicare is primary or what happens to the dependents on your plan when you enroll in Medicare, feel free to send an email to hr_employeebenefits@panynj.gov and we'll be happy talk with you about it.

Don't forget! If you are planning or recently moved, please make sure you notify HR by submitting a completed Change of Address form. Additionally, you must notify the pension system (NYSLRS and/ or RRB) about your change of address separately.

Editor's note: For those retirees working elsewhere after age 65 and covered under another employer plan, please contact Social Security, Port Authority Employee Benefits and the active plan administrator for details on requirements for enrollment in Medicare and coordination of claim submissions.

New Contact email for Human Resources Employee Benefits hr_employeebenefits@panynj.gov

As noted in the above article, Employee Benefits has provided us with a new email address for use by employees and retirees. The new email address is hr_employeebenefits@panynj.gov and is the preferred method for contacting Employee Benefits. The telephone number remains the same and it is 212-435-2870. If a retiree requests a status or address change form, Employee Benefits will either email or mail the form to your home. Forms may also be found on the PARA website. To return forms by email, you can either attach the completed form to the email or you can take a picture of the completed form (including a signature) using a cell phone and forward that image to Employee Benefits at the new email address. Other benefit questions or issues can be sent to the new email address as well. For questions that pertain to Payroll such as W-2 forms and tax related issues, retirees can contact the Payroll Department at 201-395-3173.

CVS and United Healthcare

Planning to get a vaccine at a CVS Pharmacy? What you need to know before you go.

If you are not enrolled in Medicare, and go to CVS for vaccinations, please be advised that CVS Pharmacies are no longer participating in UnitedHealthcare (UHC) 's National Medical Benefit Agreement, which means that UHC members can no longer obtain preventive vaccines at CVS Pharmacies, except for the COVID-19 vaccine. UHC members can still obtain prescription medication at CVS Pharmacies. If you are a UHC member in need of a preventive vaccine, please visit www.myuhc.com to find a participating pharmacy. Please note that vaccines are covered solely through UHC and not covered under our prescription plan with Express Scripts. Plan ahead so you are not stuck with the bill. Retirees on Medicare can still get vaccines at CVS which Medicare Part B will cover.

Medicare B Reimbursement Program Deadline Reminder March 31, 2022 for 2021 premiums

Eligible Port Authority/PATH employees who retired after July 1, 2000, and are age 65 or older, may receive reimbursement for their Medicare Part B premiums. This benefit will also be provided to their eligible spouse at age 65 once the retiree reaches age 65. HealthEquity, formally known as Wageworks, administers this benefit for the Port Authority of NY & NJ and will send a welcome package once a member becomes eligible with details on the required documentation needed to process the 2021 reimbursement. The deadline for submission for the 2021 reimbursement is March 31, 2022. HealthEquity representatives may be reached at (877) 924-3967. Claims can be submitted on the HealthEquity website by logging into your account at www.HealthEquity.com/Wageworks. If you require a hard copy form and prefer to mail in your reimbursement request, please reach out to HealthEquity directly, once you are ready to process the request.

Annual reminders will not be sent out for this program. It is the responsibility of the eligible member to submit for their reimbursement annually.
