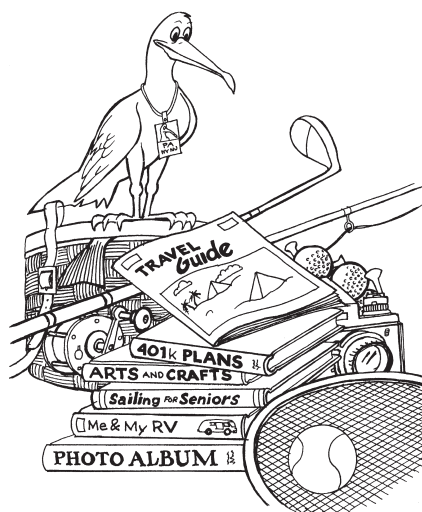

## A Message From Your President

### 2022 Goal: Expand Membership and Services

As I come up on my first year as President of PARA, I am looking back at our history, at how much has changed, where we are today, and where we might be going in the next few years. PARA is more than 30-years-old and continues to be run by an all-volunteer Board of Directors, with no staff. It speaks to a dedication to help others in the Port Authority community of retirees, using our collective knowledge to advocate on behalf of this community.

So very much has changed over these more than three decades, such as how we communicate and do business in our daily lives. Back then, who would have ever thought that a pocket-sized device would serve as the keeper of our cherished family photos? Many other aspects of our lives have changed dramatically, accompanying the advances in communication technology. Banking, filing forms, updating contact information, getting news feeds, exchanging updates with family and friends, shopping for just about anything and many other activities of daily life have moved to online transactions.

Trends, accelerated by the COVID pandemic, also include online interviews for job applicants, virtual staff meetings, and online pre-retirement seminars at the Port Authority, as well as moving current employees to an automated system for updating their own contact and benefits information through a secure online portal. This isn't unusual, of course. Lots of organizations have been doing this for years. Many of us use online access for Social Security, Medicare, banking and other financial matters, changes of address etc. Keeping the personal touch, which was such a meaningful and significant part of our century-old Port Authority culture, is difficult. This is something that the PARA Board has tried its best to maintain in our relationship with its members.

This newsletter is an example of sticking with traditional media in the form of a printed newsletter, sent via post, twice a year. It is costly, but we think it is worth the extra cost and effort to reach you all in a more concrete way. Sixteen years ago our volunteer webmaster, Joe SanSevero, created PARA's website ([www.paranynj.org](http://www.paranynj.org)) which retirees rely on for benefits forms, benefits explanations, contact information, news, PARA newsletters, bulletins, PA News archives, and the *In Memoriam* posts and archive. Nearly 12 years ago, we launched our eBulletins as a way to send time-sensitive news that couldn't wait for the print and mailing cycles of *PARA-phernalia*.

your ballot for your vote to be counted. We always encourage members to exercise their right to vote and to play an active role in PARA.

We especially urge that you keep your PARA information current. We see a steady trickle of returned newsletters from members who have relocated without sending a post card or email with their new address. Our having an email address for you is becoming more important, as we look forward to sending eBulletins on benefit issues and PANYNJ developments of concern to retirees. If you are paying 2022 dues along with the PARA election enclosures, you can update your address on the dues-remittance card.

# Board Highlights

Both the October 14, 2021 and the January 10, 2022 Quarterly Meetings of the Board of Directors were held via Zoom technology. Highlights of the October meeting are as follows: Maria Malone-Hodges was appointed to fill the second Vice-President position of PARA and joins Vice-President Rae Ann Hoffmann in the disposition of those responsibilities. Treasurer Isaacs reported a first-quarter expense of \$5,000 which is the honorarium for our webmaster. Earnings on investments are low due to low interest rates. Otherwise, there was nothing out of the ordinary for this quarter.

The insurance policy on PARA Directors and Officers has been paid. Director Hoffmann suggested an operating directive regarding retainage of the insurance policy and Director Somerwitz suggested a compilation of annual memberships and dues so the Board can approve a resolution continuing those memberships and dues payments. This will be done at the next meeting.

President Eastman reported that the newsletter will contain information regarding the ordering of centennial coins, books, and other pertinent Centennial information noteworthy to retirees. Directors Hoffmann, Isaacs and DeLaura are putting together a list of members with emails and contact information and will try to update all membership information and status changes so that we can reach as many retirees as possible with information. Director Malone-Hodges continues to promote PARA membership to potential retirees. Director Hoffmann reported that the new website status is ongoing. There are several tasks needing completion in order to continue this process and this is being worked on.

Director DuBrow has had several Zoom meetings with PA Human Resource staff regarding the new retiree Benefits Portal which HR is trying to establish. This will permit retirees to access important information and get reminders of deadlines for processing certain benefit programs. As part of this process, the Service Delivery area will be eliminated and will be replaced by "HR Connect," which will handle non-benefit related issues and "Benefits," which will handle Medicare, Wellness (claims, health and dental issues, life insurance) and retirement issues. The Benefits Division will be managed by Stella Cicchetti and a 3-member team. PARA will add this information to its website and issue an eBulletin with all the pertinent information.

In preparation for the Retiree Portal, Benefits will need updated email addresses and phone numbers for all retirees. The best way to accomplish that is for retirees to download a copy of the Port Authority Retiree Address Change Form, which is on the PARA website, print it out, complete it, making sure it is signed by the retiree or surviving spouse, and send it via email to the new address listed above. Rita is also working with Benefits on a new on-going column for each

newsletter called "For Your Benefit" in which we can cover upcoming important topics, reminders, and updates.

Director Malone-Hodges reported no upcoming pre-retirement seminars at this time. Hopefully, HR will complete a schedule for 2022 shortly. Director Hadley-Bailey will take over the Chairmanship of the Membership Committee and will work closely with Director Malone-Hodges on this effort. As before, PARA participated in the 9/11 events commemorating the Twentieth Anniversary of the attacks. Both Frank Lombardi and Peter Rinaldi spoke at these events along with other retirees. Peter spoke of the amazing resilience of the Port Authority staff during both the 1993 bombing and the 9/11 terrorist attacks. He stressed that the impacts of the changes and advancements made after the '93 bombing saved countless lives on 9/11. The Leadership Fellows of the Port Authority did an outstanding job in putting these successful events together considering they were young children when it actually took place.

At the January Meeting Director Isaacs reported no unusual expenditures in the 2021 financials. Interest rates remain low and revenue from dues was down by 25 percent. PARA membership seems to be decreasing overall. Much of the current membership doesn't pay dues and this needs to be addressed. Several ways to accomplish this were discussed. The Finance Committee looked into alternative dues payment methods and decided it would not be prudent to offer at this time because the current record keeping system would be difficult to modify. Alfred Doblin of the Media Relations Department is creating a Port Authority Archive and may be looking for information and/or artifacts.

Director DuBrow reported that the PARA website has been updated with new information supplied by HR Benefits. She has gotten positive feedback from those using the new benefits email. Those requesting reimbursement for Medicare Part B have until March 31, 2022 to apply. No further notifications of this deadline will be sent by HR. PARA will send an eBulletin reminding members.

PARA authorized recurring annual expenditures for 2022 in the following amounts, subject to payments of a contingency to cover actual increases in such fees/payments which will be reported to the Board and acted on separately – New York Council of Non-Profits (NYCON) - \$60; Alliance of Public Retiree Organizations of New York (APRONY) - \$250; Constant Contact - \$546; Zoom - \$150; and Great American Insurance - \$669. Director Somerwitz reported that Hear in America has been integrated with TruHearing and the primary contact is Katy Bova-Picuri. PARA continues to try to reach all potential retirees in order to increase membership by attending all PA and Police pre-retirement seminars.

## Updates from Human Resources – Employee Benefits

## Prudential Group Life Insurance Group Contract Number 10493

Life insurance is a valuable and important part of the PANYNJ comprehensive benefits package. The Prudential Insurance Company of America is the insurance company that the Port Authority has selected for this purpose. Prudential also provides administrative services in connection with insurance claims, as well as beneficiary changes.

In addition to keeping your current address on file with the Prudential Life Insurance Company, it is also important to keep your beneficiaries up to date and inform family members about your Life Insurance Benefit. You may view or change your beneficiary online at the Prudential website.

To view or change your Beneficiary online over the Internet:

1. Access the Beneficiary Designation website at [www.prudential.com/mybenefits](http://www.prudential.com/mybenefits)
2. Select "Register Here"
3. In the Control Number field, please enter 10493. Click next.

4. Complete the required information on the following screen and create a personal User ID and personal password.

**NOTE:** Be sure to submit your beneficiary designations when you are making any changes.

For more information or any questions, or to request a printed copy of a Booklet-Certificate for the plan details, please contact the Customer Service Office at (800) 778-3827 Monday through Friday 8:00 am until 8:00 pm Eastern Time. If using a telecommunication device for hearing impaired (TDD), please call (800) 496-1214 during the same time period. The address for Prudential is: The Prudential Insurance Company of America, Record Keeping Services, P.O. Box 13676, Philadelphia, PA 19176.

To reduce or cancel your Life Insurance, you must contact the Benefits Customer Care & Solutions Unit in HR at the Port Authority and submit a letter in writing indicating any changes you wish to make, and they would be irrevocable once implemented.

It is also important to note that each year the Port Authority Payroll Department will send a W-2 form, Wage and Tax Statement to retirees indicating their tax liability for insurance amounts that are taxable over \$50,000 and are also reported to the IRS. This income is known as "imputed income." Therefore, it is important to provide a correct address to the Port Authority to make sure that you receive this document, if applicable.

In the event of a retiree death, both the Port Authority and the Prudential Insurance Company must be notified.

## Harbor Tug Renamed for Port Dept. 9/11 Hero



Current and former Port Authority Port Department leaders joined executives of Centerline Logistics on April 15th for a ceremony renaming one of the company's harbor tugboats for William F. Fallon, Jr., a respected strategic analyst and industry-relations manager who was the only member of the department to perish during the attacks on the World Trade Center twenty years ago. Fallon had guided colleagues out of the WTC after the 1993 bombing and again assisted others in escaping the building on 9/11.

Gathering at Berth 8 at Port Newark, speakers at the event included former Port Department Director Rick Larabee. Father John Corbett, the port Chaplain, blessed the vessel. Port Authority bagpipers joined the ceremony. Bill's widow Brenda Fallon christened the newly named tug, which will work the waters of the bistate harbor. NYFD and New Jersey fireboats saluted with their water cannons offshore.
